WE DO SO BY DELIVERING OR SERVING FOOD DIRECTLY OR THROUGH COMMUNITY PARTNERS AT REGIONAL FOOD PANTRIES, LOCAL FOOD PANTRIES, SCHOOL PANTRIES, OUR TAMPA WAREHOUSE, AND THREE TRINITY CAFES. DURING THE FISCAL YEAR ENDING JUNE 30, 2023, WE DELIVERED OVER 102 MILLION POUNDS OF FOOD, GROCERIES, AND SNAP APPLICATION SUPPORT THAT TRANSLATED INTO APPROXIMATELY 85 MILLION MEALS.
